#### **Canada Reconciled: A Youthful Vision of Hope for the Future**

#### Superintendent of Schools/CEO Year In Review

The Superintendent of Schools/CEO provided an overview of the 2023/2024 school year identifying student achievements, special events, and business involving the Board of Education.

#### Superintendent of Schools/CEO Report on Student Achievement 2024

Presenter: Kevin Kaardal, Superintendent of Schools/CEO

The Superintendent of Schools/CEO provided a PowerPoint presentation on student achievements in the 2023/2024 school year. Many areas of focus were highlighted, including early learners, Indigenous students, newcomers to Canada, international students, dual credit options and post-secondary trends. Statistics on literacy, numeracy, foundation skills assessment and core competencies were provided. The six-year completion rate for all Central Okanagan students is 96%, which is 3.7% above the provincial average. The six-year completion rate for Indigenous students is 81%, which is 6.5% above the provincial average.
